The Architect Selection Committee interviewed six finalists for the project. After interviewing the firms, the committee is recommending working with J2 Studio at Centennial and ACI at Grimsrud. In addition, the committee recommended that if the Board decides to implement the master plan at Northridge that it continues working with Übl Design Group.

Recommendation: It is recommended the Board select J2 Studio for master planning at Centennial and ACI for master planning at Centennial and direct administration to hire and negotiate a contract with both J2 Studio and ACI.
