<u>Background Information</u>: United Sound Presentation (<u>Attachment</u>) Jeremy Overbeck, Horizon and Century Orchestra Director, and orchestra students from Horizon Middle School will present information on the United Sound Program. United Sound is a peer mentoring group that pairs three orchestra students with a student in the special education program and teaches them how to play a string instrument.

 North Dakota Remedial Math Report (Attachments <u>#1</u>, <u>#2</u>, <u>#3</u>, <u>#4</u>, <u>#5</u>) <u>Background Information</u>: In response to the North Dakota University System data regarding the rates of BPS graduates needing to take remedial mathematics, a team of teachers and administrators from across the district will present information regarding the work of the K- 12 Vertical Mathematics Alignment Team and other efforts taken to address student mathematic achievement.

E. Middle School Change Orders (Attachments <u>#1</u>, <u>#2</u>, <u>#3</u>)

<u>Background Information</u>: The first change order considers eliminating the acid waste piping and neutralizers at all three middle schools for a combined credit to the contract in the amount of \$80,038.76. The second change order considers additional window flashing at an addition to the contract of \$2,856.92 and eliminating countertops and brackets in the teacher prep rooms for a credit to the contract in the amount of \$2,811.41.

Recommendation: It is recommended that the Board approve the Horizon Middle School Change Order M-01 for a credit of \$20,718; the Simle Middle School Change Orders M-02 for a credit of \$32,228, G-08 for an addition of \$2,856.92, G-09 for a credit of \$2,811.41; and Wachter Middle School Change Order M-02 for a credit of \$27,092.76.

- C. Middle School Furniture Bids (Attachment)

<u>Background Information</u>: Bismarck Public Schools opened bids on January 12, 2018, for furniture to be located at Horizon, Simle, and Wachter Middle Schools. We received either full or partial bids from four companies.

Recommendation: It is recommended that the Board approve the low bidders as follows: Brown & Saenger in the amount of \$138,805.53; Fireside Office Solutions in the amount of \$97,569; Rough Rider in the amount of \$14,586.60; and School Speciality in the amount of \$20,185.24, for a total of \$271,146.37.

 D. Century High School Flooring (<u>Attachment</u>) <u>Background Information</u>: The district recently solicited bids for flooring in the Century High School commons area. We received bids from four companies. The apparent low bid was from Hruby Flooring.
 Performed at the second and that the Board award Hruby Flooring the CHS flooring.

Recommendation: It is recommended that the Board award Hruby Flooring the CHS flooring base bid of \$65,840 and the add alternate bid of \$8,286 for a total amount of \$74,126.

E. Wachter Middle School Casework (Attachment)

<u>Background Information</u>: The district recently solicited bids for casework to be placed in the renovated counseling area and science room at Wachter Middle School. We received three bids. **Recommendation:** It is recommended that the Board award TMI Systems the bid for WMS counseling area and science room casework in the amount of \$37,880.

F. Dorothy Moses Elementary School Roof Replacements (<u>Attachment</u>)
 <u>Background Information</u>: The district opened bids on February 7 for the Dorothy Moses
 Elementary School reroofing. We received bids from five companies. The apparent low bidder was Twin City Roofing.

Recommendation: It is recommended that the Board award Twin City Roofing the Dorothy Moses Elementary reroofing bid item 1 and bid item 2 in the amount of \$271,430.
