The Bismarck-Mandan MPO Policy Board on <u>Tuesday</u>, <u>April 21</u>, <u>2020</u>, <u>at 1:30 PM</u>. The meeting will be held in the Tom Baker Meeting Room of the City/County Office Building at 221 N. 5<sup>th</sup> Street, Bismarck, ND. The agenda is outlined below.

Due to ongoing public health concerns related to COVID-19, the City of Bismarck is encouraging citizens to consider alternate means to attend the meeting of the Metropolitan Planning Organization Policy Board.
