The Bismarck-Mandan MPO Technical Advisory Committee will meet on <u>Monday</u>, <u>April 20, 2020, at 10:00 AM</u>. The meeting will be held in the Tom Baker Meeting Room, City/County Office Building at 221 N. 5<sup>th</sup> Street, Bismarck, ND.

Due to ongoing public health concerns related to COVID-19, the City of Bismarck is encouraging citizens to consider alternate means to attend the meeting of the Metropolitan Planning Organization Technical Advisory Committee (TAC). The physical meeting room will be open to the public, but we certainly understand the public wishing to limit their exposure at this time but still participate in government. Before entering the City/County Building, all individuals will be screened for COVID-19 and if unable to pass the screening protocol, will be requested to participate remotely in the meeting for the public's safety.

Many of the fourteen (14) TAC members will attend this meeting remotely. The number of participants to be in person will be physically limited to a maximum total number of occupants in the meeting room to ten (10) but live simulcasting (video + audio) of the meeting into other parts of the City/County building will be available if that number is exceeded.
