- Request Board Authorization to Apply for the Following Grants:
 - O Park District Facility Renovation Grant through ND Parks and Recreation Department The North Dakota Parks and Recreation Department Park District Facility Renovation Grant (PDFRG) offers local park districts the ability to compete in one of two population categories. The Park District would apply in the population center of 15,000+. The authorized \$5,000,000, 50% matching grant is strictly limited for renovation, upgrade, and/or repair of existing facilities with the priority given to outdoor facilities. For renovation, repair or upgrade of park district facility projects, \$1,000,000 is the maximum grant amount. Park District staff has identified \$2,000,000 in projects for which we could apply. Staff requests Board authorization to apply for this funding.
