NDCC 55-02-07 Review Requests: City of Bismarck Proposed Disposition of Land to Bismarck State College

The City of Bismarck has submitted a review request to the State Historical Society of North Dakota under North Dakota Century Code (NDCC) 55-02-07 (*Protection of historical or archaeological artifacts or sites*) for a proposed transfer of land owned by the City to Bismarck State College. The City has been notified that this transfer of land out of City ownership does constitute disposal of property subject to NDCC 55-02-07 and that there are known archeological sites identified.

As a reminder, NDCC 55-02-07.1 (*Protection of prehistoric or historic site locational data*) states:


The director of the state historical society may limit access to, and release of, information from files of the state historical society which contain data that specifically identifies the location of archaeological, historical, or paleontological sites in North Dakota. No access to, or release of, information from files that contain site-specific locational data may be made until the director is satisfied that the applicant has a reasonable need for the information contained in those files and professionally acceptable qualifications to assure that release of the information will not result in unnecessary destruction of the resource.

Section 2-12-02 of the City of Bismarck Code of Ordinances – Historic Preservation, Purpose and Declaration of Public Policy states:

It is intended that the Historic Preservation Commission will cooperate with and assist various local, state and federal entities and agencies in the enforcement of local, state and federal legislation to identify, evaluate, designate, and safeguard properties significant in the pre-history, history, architecture, engineering and culture of the community, state and nation.


